CRITERIA

Nominee has demonstrated

- Demonstrates a spirit of compassion and caring, dedication and resourcefulness, resource utilization
- Collaborates with health care professionals in providing optimal care
- Recent achievements supporting future growth and success of STTI and the nursing profession accomplished through the nominee's ability to influence outcomes and people
- Transforming change that has resulted from the nominee's influence on people, organizations or situations
- A positive vision for leadership and a continuing commitment to leadership activities
- Knowledge, skills and abilities related to personal, interpersonal, organizational and civic/service leadership development
- Volunteer service resulting in the advancement or promotion of STTI, the nursing profession or health care
- Dedication and commitment to ongoing volunteer service
- Personal growth and renewal through volunteer and/or leadership activities

SUBMISSION REQUIREMENTS

- A complete nomination consists of:
- Online entry form and payment
- Supporting narrative that addresses criteria (1-2 pages)
- Three (3) letters of support addressing how the new member meets the criteria
- Letter of acceptance
