Geriatric Nursing Leadership Award

PURPOSE

The Geriatric Nursing Leadership Award honors an emerging nurse leader who demonstrates significant contributions to the health care of older adults through exemplary vision, influence, critical thinking, communication and role modeling. The nurse leader demonstrates commitment to gerontological nursing as a member or leader of an interprofessional team. This individual creates an important impact through policy, system or practice change within an organization.

This award, including a US \$2,000 stipend, will be presented during the Sigma Theta Tau International biennial convention, and the recipient will be invited to make a presentation of his or her work. The recipient will also receive complimentary registration to the convention, as well as a commemorative award. The award is supported through a grant to Sigma Theta Tau International Foundation for Nursing by The John A. Hartford Foundation.

ELIGIBILITY

Must be a nurse and a member of Sigma Theta Tau International. (Honorary members are eligible.) Any member or chapter may nominate. Self-nominations are invited.

CRITERIA

- The individual influences geriatric care and outcomes through membership in or leadership of an inter-professional team. The individual influences geriatric health care practices within a clinical setting.
- The individual improves geriatric health outcomes through leadership and enactment of evidence-based care.
- The individual disseminates "lessons learned" in leadership development or geriatric care delivery.

JUDGING

Judges will include the members of the Geriatric Nursing Leadership Academy Advisory Committee.

SUBMISSION REQUIREMENTS

A complete nomination consists of:

- Online entry form
- Supporting narrative that addresses criteria (1-2 pages)
- Three (3) letters of support representing different perspectives
- Nominee's curriculum vitae
- Supporting documentation that provides direct evidence of the nominee's contributions to gerontological nursing (not to exceed 10 pages)
- · Letter of acceptance
