Chapter Spirit of Philanthropy Award

PURPOSE

The Sigma Theta Tau International Foundation for Nursing presents the Chapter Spirit of Philanthropy Award to honor chapters (not individuals or a group of individual members) that have successfully maintained sustainability while implementing a philanthropic project with the philanthropic support of a majority of its members.

The **project or group of projects** should involve the contribution of a majority of the chapter members' time, talents and/or funds to cause(s) that advance <u>STTI's mission</u> to support the learning, knowledge and professional development of nurses committed to making a difference in health worldwide.

ELIGIBILITY

All active chapters are eligible for this award. This award recognizes chapter activities from 1 March 2011 through 1 March 2013.

A chapter that received a previous Spirit of Philanthropy Award for a project or multiple projects is not eligible to submit the same project or projects for a second award, even if the project is ongoing. Significant enhancements to a previously awarded project or projects will be considered.

NOMINATIONS

Any chapter member or officer may nominate.

CRITERIA

• Exemplifies and inspire the spirit of philanthropy, defined as "voluntarily giving human or financial resources to promote the common good."

• Portrays a positive image of nursing.

• Advances STTI's mission to support the learning, knowledge and professional development of nurses committed to making a difference in health worldwide.

• Advances STTI's presidential call to action.

• Involves at least 50% of chapter members toward the chapter's sustainability and chapter-endorsed project(s).

SUBMISSION REQUIREMENTS

Supporting documents required below must address the criteria. A complete online nomination consists of:

- Online entry form* and payment
- <u>Any other supporting documentation</u> (not to exceed 10 pages)
- Letter of acceptance
